



ROKiT WEBSITE ACCEPTABLE USE POLICY

This Acceptable Use Policy sets out the conditions between you and us under which you may access our website at <http://www.rokitphones.com/uk>(our "site"). This Acceptable Use Policy applies to all users and visitors of our site.

Your use of our site means that you accept all of the terms in this Acceptable Use Policy, which supplement our Terms of Use [[ROKiT Website Terms of Use](#)] and that you agree to abide by them.

The site is operated by ROKiT Enterprises Limited, a company registered in England and Wales under number 10800456. Our registered office and main trading address is located at ROK House, Kingswood Business Park, Holyhead Road, Albrighton, Staffordshire, United Kingdom, WV7 3AU.

PROHIBITED USES

You may only use our site for legal purposes. You cannot use our site:

- In a manner that violates any applicable local, national or international law or regulation.

You also accept the following:

 - Do not access without permission, interfere with, damage or disrupt:
 - any part of our site;
 - any equipment or network on which our site operates from or is stored;
 - any software used in the provision of our site; or
 - any equipment, device or network or software owned or used by a third party.

INTERACTIVE SERVICES

- Be likely to harass, annoy, embarrass, alarm or annoy any other person.
- Be used to impersonate a person, or misrepresent your identity or affiliation with anyone.
- Give the impression that they emanate from us, if this is not the case.
- Advocate, promote or facilitate any illicit act such as (for example only) infringement of copyright or misuse of computers or devices.

SUSPENSION AND TERMINATION

We will determine, at our sole discretion, whether your use of our site has violated this Acceptable Use Policy. When a violation of this policy has occurred, we may take action that we deem appropriate.

Failure to comply with this Acceptable Use Policy constitutes a material breach of the Terms of Use [[ROKiT Website Terms of Use](#)] on which you are authorized to use our site, and may cause us to take any or all of the following actions:

- Immediate, temporary or permanent withdrawal of your right to use our site.
- Immediate, temporary or permanent withdrawal of any display or material downloaded by you on our site.
- Issuing a warning for you.
- Legal action against you for the reimbursement of all costs on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from the breach.
- Other legal proceedings against you.
- Disclosing such information to law enforcement authorities if we deem it necessary.
